**Visottica Industrie Spa Informative Report according to the provisions of Consumer Product Safety Improvement Act of 2008 (CPSIA)**

Dear Customer,

Visottica Industrie Spa is fully aware of the following American laws:

- a. Consumer Product Safety Improvement Act of 2008 ("CPSIA"), and
- b. Code of Federal Regulations, Title 16, Chapter II, Part 1303 ("CFR 1303 – Ban of Lead-containing paint and certain consumer products bearing Lead-containing paint"), and
- c. Code of Federal Regulations, Title 16, Part 1307 (Prohibition of Children's Toys and Child Care Articles Containing Specified Phthalates)

Visottica Industrie Spa closely observes the development of these laws for what concerns restrictions both on Lead and on Phthalates content.

In accordance with the Consumer Product Safety Improvement Act of 2008 (CPSIA), the USA Consumer Product Safety Commission issues this final rule **Code of Federal Regulations, Title 16, Part 1307** prohibiting children's toys and child care articles containing concentrations of more than 0.1 percent of certain phthalates.

Visottica Industrie Spa specifies that according to Consumer Product Safety Improvement Act of 2008 (CPSIA), and up to the date of revision of this document, the spectacles components produced and/or commercialized included in the catalogue "Comfort for the vision 2019" and "Components for frames 2019":

- do not contain the following phthalates at concentrations of more than 0.1 percent:
  1. di-(2-ethylhexyl) phthalate (DEHP);
  2. dibutyl phthalate (DBP);
  3. benzyl butyl phthalate (BBP)
  4. diisononyl phthalate (DINP);
  5. di-n-pentyl phthalate (DPENP);
  6. di-n-hexyl phthalate (DHEXP);
  7. dicyclohexyl phthalate (DCHP);
  8. diisobutyl phthalate (DIBP).

- do not contain Lead (CAS No. 7439-92-1) with standards higher than the restrictions cited by the Consumer Product Safety Improvement Act of 2008 (American "CPSIA"),
- with the exception for the following articles in bronze which contain Lead beyond the limits fixed by CPSIA (max 0,02%):

  - 05WF90112000
  - 05WF90112001

At the same time, Visottica Industrie Spa wants to declare that also some articles that are not present neither on 2017 Visottica/Comotec catalogue nor in 2017 nose-pad and pad-arm catalogue may contain Lead in a concentration higher than the restrictions fixed by CPSIA. In case of specific request made by the customer, Visottica Industrie Spa is fully available to supply information about the possible Lead presence in these articles.


